DECISION:

Item No. (1) of the minutes of the Standing Equivalence Committee was not acceded to & the Council advise that the applicant should first qualify MCs in order to become eligible for admission to MS Computer Sciences.

Item No (2) regarding equalvilance of BS & M.Sc Genetics to BS & M.Sc Biotechnology, Biology as well as Plant Breeding Genetics was approved.

Item No (3) regarding migration was not approved being time barred.

Item No (4) regarding migration from VU University to Hazara University the Council decided that it can't be allowed due to different system of education.

Item No (5) regarding equivalence of crop verity Hasnain 2013 the Council decided that a committee comprising Prof. Dr. Bakhtiar (Chair), Dr. Fida Abbasi, Dr. Manzoor & Prof. Dr. Zahoor Swati should sort out the matter & submit its report to the next meeting.

Item No. 4. GRE TYPE SUBJECT TEST IN GENETICS

The Chairman, Department of Genetics had submitted a request vide letter No. 02/HU/Gen/2012/7389 dated July 05, 2012 regarding conduct of GRE type test by the Department of Genetics for admission to Ph.D. A Committee for the purpose was already approved by the HEC vide letter No. 1-3/DD-QA/HEC/2011/217 dated April 26, 2012.

The case was placed at Pages15-16 to the Academic Council for information please.

DECISION:-the Council concurred the approved committee already notified by HEC to conduct GRE (subject) test in Genetics for admission to Ph.D.

Item No. 5. APPROVAL OF ESTABLISHMENT OF DEPARTMENT OF SOCIOLOGY

The Chairman, Determent of Political Science has submitted request for approval of the Department of Sociology in Hazara University. The Hon'ble Vice Chancellor has already approved the establishment of Sociology department in anticipation. The department intend to start classes from Fall Semester 2013 in response to the advertisement of admission in the discipline of Sociology 09 M.Phil & 02 M.Sc application have been received the program will be started under the department of Political Science having rich faculty for the said discipline.

The case was placed at Pages17-18 to the Academic Council for approval please.

DECISION: The Council approved the establishment of department of Sociology.

Item No. 6. REQUEST OF THE STUDENTS OF PHARM-D 5TH PROFESSIONAL DEPT. OF PHARMACY HAVELIAN CAMPUS

The students of Pharm-D, 5th Professional, Department of Pharmacy, have submitted an appeal to the Honorable Vice Chancellor where in they state that they have failed in one paper of 4th Professional and according to rule 1.2.6.8 ***"A student will not be allowed to appear in the 5th Professional Exam unless he/she passes all subjects of 1st to 4th Professional exams"***

So in view of the above rule the department forbidden them to sit in the 5th Professional annual exam unless they pass the remaining one paper of 4th Prof. They further stated that according to the rule 1.2.6.7 ***"Any student who is failed in any subject of 4th Prof. Shall not be allowed to attend classes of 5th Prof."***

So in violation of the above rule they had been attending classes as they were not forbidden by the dept. to do so.

They also declare as follows:

1. that they were not informed about the rules earlier.
2. that they had submitted all dues of 5th Prof.
3. that they had completed 75% attendance in 5th Prof.
4. that they were enrolled in Pharm-D program in spring 2008 & thus 05 years duration of the program has been completed.

At the end they pray that they may be allowed in the upcoming annual exam of 5th Prof. on compassionate ground as an exception and they shall clear their one paper of 4th Prof. in the subsequent supply exam.

The case was placed at **Pages 19-20** to the Academic Council for decision please.

DECISION: The Council did not accede to the request of the students of Pharm-D program.
