## ToRs:

- The payment of allowance admissible under the scholarship program shall be made subject to complete adherence towards rules and regulations governing the scholarship program, as well as satisfactory performance in the authorized studies.
- 2. The student shall not change the specified course/s of studies nor register himself/ herself for any other course or program/institute without prior approval.
  - The student shall not extend the specified period of study without prior approval of Funding Agency.
    In case of selection in any other scholarship scheme, the student will immediately report the same to the university.
  - 4. The Funding Agency/ University reserves the right to recover all the payment received or impose a penalty equal to the total scholarship amount in addition to the scholarship amount received by the student, in case the scholar fails to qualify for the course / degree for which he/she was awarded the scholarship.
  - 5. The parents/ guardian of the scholarship awarded students are unable to financially support their education at the university.
  - 6. The scholarship shall be terminable in the following situations/scenario.
    - a) If the student fails to maintain required class attendance of 75%, in each semester.
    - b) If the student is involved in malicious / subversive / undesirable activities.
    - c) If the student fails to obey / act in accordance with HE Funding Agency/ University order / directives, he/she will be liable to strict action, under the prevailing rules of the university.
